**Make it GRAND-Parent Essay Winners Announced**

The \$500 Grand Prize Essay winner was Alexis Sattler, 17, a student at Kingsley High School. “Her essay about her grandmother was exceptionally touching,” said Deborah Allen, community engagement officer for Grand Traverse Pavilions.

Alexis excelled over the field of 16 responses from age groups 7 – 18+. The runners up were Ruth Fiona Paddock in the 7-10 age group, Ava Higgins in the 11-17 age group, and Ashley Anderson in the 18+ group.

Allen sends her congratulations to all of the winners, and whole heartedly thanks all of the students who submitted essays. “Every grandparent celebrated represents the loving impact they have had on their families,” she said. “This Sunday, Sept. 12, 2021, is National Grandparents Day – a perfect time to tell your beloved grandparents how much you appreciate them!”

“The **“MAKE IT GRAND-Parent Essay Challenge”** was geared toward all ages to celebrate the legacy and impact that our elders – specifically grandparents – have had on us,” Allen said.

The Make it Grand-parent promotion was meant to celebrate the relationships and importance of grandparents at a time when national trends are demonstrating that more grandparents are actually helping or taking responsibility for raising their grandchildren.
