Family Updates

Testing Results

We are saddened to report that after almost 20 months of being COVID free during this pandemic, we are experiencing our first outbreak. Starting November 5th we have had 33 residents and 11 staff testing positive for COVID-19. This outbreak started in our vaccinated population. We only have 1 unvaccinated resident who did not test positive until earlier this week. Three residents were hospitalized and one has since been readmitted.

Three residents have passed outside of our facility. We have

employees, 4 were exposed outside of our facility. We have completed genotyping with our positive cases both residents and staff. The results is a Delta Variant that appears to be vaccine resistant. Residents are being tested almost daily and staff are tested twice weekly. Anyone either staff or residents is tested when they are symptomatic. Our county positivity rate was 19.41% on November 22nd. CMS shows our facility as having 99.3% of residents and 80.1% of staff vaccinated as of November 7, 2021



Visitation

We continue with electronic visits between the residents and their families. Due to the continued outbreak we have suspended all visitations to mitigate the spread. Facility policies are available on our website under the Family Weekly Update tab. CMS and MDHHS have issues new visitation guidance however we are awaiting the guidance for implementation.
