

This form will be updated at least bi-weekly (1st and 3rd Monday of the month) in conjunction with posting of CDC transmission rates or as needed for facility outbreaks and posted on the COVID-19 bulletin board to inform staff of current status and related expectations. **Any decreases in spread rate need to be maintained for 14 days to be able to begin prevention/control measures for the decreased rate.**
