Family updates

Testing Results

We have had five staff members test positive since the last report, with the most recent being a fully vaccinated employee that was tested on September 3rd. This individual works in our finance office and poses no exposure to our residents. All individuals on the Pavilions work roster, whether they have worked recently or not, are on-call, part-time or full time, that have not been fully vaccinated are required to be tested for COVID-19 weekly. Because there were two positive staff members who tested positive within two weeks of each other, all individuals on the Pavilions work roster must test twice weekly. CMS's published positivity rate for Grand Traverse County increased to 6.6% as of September 7th.

Vaccinations

CMS shows our facility as having 98.2% of residents and 77.7% of staff vaccinated as of August 22. The percentages fluctuate depending on employment status and new admissions and discharges. Our contract pharmacy provider, Hometown Pharmacy, has Johnson & Johnson COVID vaccine available to be administered to our new residents and for new or current staff that choose to be vaccinated. Vaccination does not preclude staff or residents from adhering to current infection control practices or relieve staff from wearing required PPE.

It was recently announced that nursing home workers will be mandated to be vaccinated in order to work in our facility. At this time we do not know what the regulation will state, what exemptions will be allowed or any other parameters surrounding the announcement. We are working with our pharmacy to set up the process so we are ready when the rule becomes published. Additionally, it is now mandated that we provide a third dose of the vaccine to those eligible (which is anyone who has received the first doses within the past 6-8 months) starting in October. Our pharmacy will be administering the vaccine along with the influenza vaccine to our residents and when enough is available will administer the COVID vaccine to staff.

Visitation

Currently we are still offering a multitude of different visitation options. These options include indoor, outdoor and community visits. At this time our current policy allows for limited indoor visits, and outdoor visits with very little restrictions for those residents who are fully vaccinated. Our current policies and updates are available on our website under the Family Weekly Updates tab. For those families who don't have the ability to visit in person electronic visits are still available.
